This CCPA Employee Addendum applies solely to all Johnson Controls employees who reside in the State of California ("you"). Information We Collect, Use and Share

During the past twelve (12) months, our practices with respect to our collection, use and disclosure of your personal information is reflected in the Johnson Controls Global Employee Personal Information Privacy Notice.

Sources of personal information

Johnson Controls obtains the categories of personal information referred to above from the following categories of sources:

- Directly from you.
- Indirectly from you and on your instruction. For example, information relating to previous employment, background checks etc.

Sales of Personal Information

Johnson Controls does not sell your personal information.

Your Rights and Choices

Access to Specific Information and Data Portability Rights

You have the right to request that Johnson Controls disclose certain information to you about our collection and use of your personal information over the past 12 months.

Deletion Request Rights

You have the right to request that Johnson Controls delete your personal information, subject to certain exceptions. After we receive and validate your request, we will delete your personal information, as well as direct our service providers to delete your personal information, unless an exception applies.

Exercising Access, Data Portability, and Deletion Rights

You may only make a verifiable consumer request for access or data portability twice within a 12-month period.

We endeavor to respond to a verifiable consumer request within forty-five (45) days of its receipt. If we require more time (up to forty-five (45) extra days), we will inform you of the reason and extension period in writing.
