Introduction

markers, polylines, ground overlays and info windows to your map. These objects provide additional information for map locations, and allow user interaction with the map.

When using the SDK you need to comply with the Google Maps Platform Terms of Service and ensure that your app complies with applicable laws. Note that when using the SDK, your application name and version, authentication information and a cross-application anonymous identifier is automatically sent with each request.

Note: Google uses cookies to gather anonymous usage statistics. You can delete cookies associated with an app by uninstalling and re-installing the app.

Audience

This documentation is designed for people familiar with iOS development and object-oriented programming concepts. You should also be familiar with Google Maps from a user's point of view.
